# **Promotion event rules**



## 1. Term definition

- 1.1. The applicant is Letiště Ostrava, a.s., with headquarters Letiště Ostrava, no. 401, 742 51 Mošnov, registered at Commercial Register administered by Ostrava District Court, section B, insert 2764.
- 1.2. The event participant is a person completing a binding booking of airplane ticket at route Ostrava Paris according to the below specified conditions.
- 1.3. Discount provided to the event participant who ordered the ticket amongst the first hundred applicants from 20.08.12 from 12 o'clock, and who completed a binding booking, therefore fulfilled the event conditions. The discount is provided for single flight at route Ostrava Paris or Paris Ostrava, or for return flight Ostrava Paris Ostrava regardless the date of the return flight.

#### 2. General rules

- 2.1. All persons accepting these conditions and the general commercial terms can participate in the event, except for the employees and their family members.
- **2.2.** Only physical entity over 18 can participate in the event, or a person over 15 under the responsibility of a legal guardian during the promotion event and the winning implementation.
- 2.3. The flight ticket must be booked only via web pages Letiště Ostrava, a.s. (<u>http://www.airport-ostrava.cz/cz/page-lette-do-parize-se-slevou /</u>), with placed booking form designed for such event.
- 2.4. The event will start from 20.08.12 Central European time.
- 2.5. The discount applies only for the first 100 binding booked and paid tickets from the date and time of the event commencement, at the latest on 23.09.12 before 23:59. The air tickets can be booked only for flights from the event commencement until 25.10.12. The binding booking is considered the completion of all obligatory data in the booking form, subsequent booking confirmation by the event 'provider and the participant, and the ticket payment within the date specified by the provider. The discount is applied to the final price of the ticket including all fees (airport fees, security fees if applicable and service fees).
- 2.6. The payment must be completed in cash at the airplane ticket counter operated by the provider in the departure hall at Ostrava airport or by bank transfer on the account of the provider.
- 2.7. In case of cancelling the booking by the event participant, his/her entitlement to discount terminates.
- **2.8.** The discount cannot be enforced by court.

#### 3. Rights and Obligations of the event participant

3.1. The event participant is obliged to provide the organizer with full and true contact data important for the flight booking, its issuance, and discount provision.

#### 4. Rights and Obligations of the provider

- 4.1. The provider is not liable for any damages which may occur to the event participant, potentially other persons in contact with the winning price.
- **4.2.** The provider reserves rights to stop, change, terminate the event without specifying the reasons, in case serious unexpected events occur or events caused by force majeure. In such case the participant has no right for any compensation or settlement.
- 4.3. The provider is not liable for any potential damages resulting from the failure of the system and program accessories which does not originate in the provider's intentional acting. In such case the provider reserves rights to stop. Change, terminate the event without specifying the reasons. The participant has no right for any compensation or settlement.

### 5. Personal data

- 5.1. All data received from the event participant are considered personal data and are subject to protection according to Act no. 101/2000 Coll. On personal data protection. The participant herewith conforms he/she is aware that the provision of data is voluntary, and he/she can access them.
- 5.2. The provider undertakes to refrain from providing personal data of the participants to third persons.

# 6. Final provisions

- 6.1. The conditions specified herein comply with applicable law and other legal regulations of the Czech Republic. The event participant upon his/her registration confirms he/she was appropriately acquainted with the conditions and undertakes to abide by them.
- 6.2. The provider reserves a right to potential changes and completion of the conditions herein. In this case, the provider will announce the changes by notification on its web pages.
- 6.3. The conditions are applicable from 20.08.12.
